Important Things to Know Prior to Installing e-ISuite Site 2.3.0

- System Requirements
 - Windows 7 Professional, Windows 10 Professional, or Windows 2016/2019 Server
 - No competing http Services (Tomcat9 will provide web services on server machine)
 - Optimal screen resolution is 1366 x 768
- Browser Requirements
 - Google Chrome or Microsoft Edge are the preferred browsers.
 - Pop-up Blockers Turned Off
- System administrative privileges **are** required to install the application.
Note: Users will need to follow their agency protocol for installing software.

Site 2.3.0 Installation Instructions

Step 1: YOU MUST UNINSTALL all previous versions of e-ISuite Site. Follow your agency protocol for uninstalling software.

Step 2: Users will be required to reboot their systems after uninstalling e-ISuite.

Step 3: Users must clear their browser cache before installing e-ISuite Site 2.3.0. Instructions for clearing browser cache in Google Chrome, Microsoft Edge and Firefox can be found here: [Clearing Browser Caches](#)

Step 4: Users may now proceed with the installation of e-ISuite Site 2.3.0. Follow your agency protocol for installing software.

Version 2.3.0 Release Summary

Functional Area	Summary
Accounting Codes	Accrual Accounting Code field was removed from the Accounting Codes tab on the Edit Incident screen.
Check-In	Fixes an issue where an error message appeared when editing a parent resource that does not have the Agency field populated.
Check-In	Cursor will now automatically return to the Request Number field when selecting “No” in response to a Duplicate Request Number validation message.
Cost	Accrual Code fields were removed from all areas in the Cost Module.
Cost	Spelling of Retardant was corrected on all Cost Reports.
Custom Reports	Fixes an issue where dates were not sorting correctly in Custom Report views.
Custom Reports	Accrual Code and Accrual Description fields were removed from the Resources-Cost Custom Report view.
Data Transfer	Fixes an issue where the Data Transfer process was not working correctly.
Demob	The system will now prevent an invalid time from being entered in the Leave ICP Time field and Flight Time field on the Air Travel Data screen.
Demob	Actual and Tentative Demob Remarks fields were increased to accept more characters and will now wrap correctly on the Available Release Report, Actual Demob Report and the ICS-221 Demobilization Checkout Form.
IAP	Added the ability to enter a Degree symbol on the ICS-206 Form Blocks 5-7.
IAP	Fixes an issue where the full Incident Name was not printing on the ICS-204, ICS-205 and ICS-220 Forms, Block 1.
IAP	Fixes an issue where Special Instructions were not displaying correctly on the ICS-205 Form.
IAP	Fixes an issue in IAP Settings where the Resource to Display From option was not displaying correctly when an Incident Group was selected.

Functional Area	Summary
Reference Data	Updated Reference Data tables to include AD Rates, Cost Rates, Item Codes, Unit ID's and FS Region/Units.
Reference Data	Fixes an issue where Logging Truck was showing under the wrong Section Code.
Site Install	Fixes an issue where a missing dll file error message was appearing during install.
Time	Fixes an issue where the Total Sort option was not sorting correctly based on Total Shift Hours on the Shifts in Excess of Standard Hours Report.
Time	Added the ability to delete multiple time postings at the same time.
Time	Fixes an issue where the Item Code was not updating correctly when overwriting an existing time posting.
Training Specialist	Fixes an issue where the Evaluator Names were not displaying in Last Name, First Name order on the Training Assignments List.
User Accounts	Fixes an issue where users who do not have the Data Manager role were able to assign all roles when bringing a new user account into Enterprise from iNAP.
